RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AND PARENTAL CONSENT AGREEMENT **("AGREEMENT")**

IN CONSIDERATION of being permitted to participate in any way in JC Sports Performance activities ("Activities") I, for myself for personal representatives, assigns, heirs, and next of kin:
